Sponsor
<p>Candidates must be sponsored by a business, relatives or by your family. Employers, business owners who are friends of the family or parents' employers are often excited to sponsor someone they know. Anyone can sponsor, and they do not have to be in Woodbury. We encourage candidates to ask local business owners. They have been wonderful supporters of our program!</p> <p>The sponsorship fee is \$300, or \$150 for a partial sponsorship. Two partial sponsorships are needed for a full sponsorship. All fees are tax deductible. The application fee is \$300 and the deadline for application is July 1, 2019. No applications will be accepted after a postmark of July 1st. In addition, there is a non-refundable \$25 commitment fee due from the candidate's family at the time of application. Please make all checks payable to Woodbury Days Council. The application fee and commitment fees are non-refundable unless the coronation is cancelled.

If there are not six (6) candidates in the Miss Woodbury and Little Miss Woodbury age categories, the program may be canceled for the following year (Aug 2019-Aug 2020). In the event this does occur, fees will be refunded.



Little Miss Woodbury Candidate Qualifications and Agreement

The Woodbury Ambassadors Scholarship Program is part of Woodbury Days Council (WDC), a non-profit organization run by volunteers who plan and organize the Woodbury Days festival. The Woodbury Ambassadors Royal Family is one of several committees who make up the WDC. As part of WDC, all rules and regulations are set forth by the Council.

While identifiable as a candidate of the Woodbury Ambassadors Royal Family, the following rules & regulations shall apply. Non-compliance of the following could result in immediate disqualification and forfeiture of the monetary gift rewarded at the end of the reign.

Qualifications
<ul style="list-style-type: none"> • Eligible grade levels: 3rd, 4th or 5th beginning this fall (2019). • Eligible school districts: 833, 834 or 622. • Not currently an ambassador (past Woodbury Ambassadors must wait one year to run again)
Attendance Policies
<p>Candidates will have the opportunity to participate in many events during the candidacy period from approximately July 6, 2019, through August 26, 2019. Candidates are encouraged to attend all events, however, if vacations or other commitments have been scheduled previously, the absences may be excused. Evenings and weekends constitute most of the appearances requested. Candidates must attend the events during Woodbury Days and the Coronation itself.</p>
Covered Expenses During Candidacy
<p>The following items will be purchased by Woodbury Days Council and provided to the Candidates.</p> <ul style="list-style-type: none"> • Sash, name badge • One polo shirt • Cinch Sack
Additional Expenses (covered by the Candidate and/or family)
<p>The Candidate and/or her family will be responsible to pay for the following:</p> <ul style="list-style-type: none"> • One pair of khaki pants, one pair of black pants • Jacket, shoes • Tea dress (Knee length or longer with minimum 1-inch straps) • Formal/Party dress for coronation



Candidate and candidate's parents agree that if she is selected as Little Miss Woodbury and is unable to commit for whatever reason, she will resign her title and all monetary and physical benefits, and the title will be given to the designated Princess who will follow in her absence.

Indemnification

To the extent permitted by law, I hereby agree to protect, indemnify, defend and hold harmless WDC and their respective volunteers against all claims, losses or damages to persons or property and costs (including reasonable attorney's fees), arising out of or connected to the reign of the Ambassadors.

This Agreement constitutes the entire agreement between parties, and there are no verbal understandings or other agreements of any nature with respect to the subject matter hereof except those contained in this agreement. It is subject to cancellation only as provided above; it may not be altered or varied by oral agreements or representations of any kind.
